The USCA requires proof of insurance from that insurance company, and the limits must be "per occurrence" of at least \$1 million general liability, 1 million legal liability, \$300K damage, \$5K medical :expenses, \$1 million personal injury, \$1 million COMP/OP AGG, \$1 million hired automobile, \$2 million excess liability, \$5K athletic participant AD&D, \$25K athletic accident excluding medical. The proof of insurance must be provided to the USCA President and must list the USCA, its Officers and Delegates as 'Additional Insured'.
9. Once an event has been officially sanctioned by the USCA:
 - a. The race sponsor may use the sanctioning and USCA emblem to promote the event. Other uses of the USCA emblem, such as advertisements for goods and services is

prohibited without prior consent of the USCA President.

- b. The race sponsor may advertise the event in the USCA's printed magazine *Canoe News*.
- c. The race sponsor may request that the event be added to the USCA website and/or USCA Facebook page.
